Present, Mayor Brenda Harrell, Donald Webb, Dennis Sugg, Barbara Taylor, and Oscar Mabry, Commissioner Pender was out of town but present via ZOOM.

Also in attendance, Town Administrator Natalie Bess, Finance Officer Tammy Keesler, and Police Chief Stacy Harrell, Also in attendance was Van Holland from the Tar River Times paper.

A. Call to Order Mayor Harrell called the June 23, 2020 Special Call Meeting to order at 6,00 p.m. She also welcomed anyone who may be attending via ZOOM.

## B. Invocation

Invocation was given by Commissioner Barbara Taylor.

#### C. Pledge of Allegiance

Mayor Harrell led the pledge of Allegiance.

#### D. Proposed Agenda

Town Administrator, Natalie Bess asked that the proposed agenda be amended to include the Capital Project Ordinance for the Well No. 4 Replacement Project. She told the board that she just received the Ordinance and it needed to be adopted by the board before the town can submit any payment requests. Commissioner Sugg made a motion to approve the proposed agenda as amended, Commissioner Webb seconded the motion. The motion passed unanimously.

#### E. Consent Agenda

Commissioner Webb made a motion to approve the minutes from the Regular Board meeting held on June 2, 2020. This motion was seconded by Commissioner Taylor, Motion carried unanimously.

#### F. 1. Public Hearing for FY 2020-2021 Budget

Mayor Harrell asked for a motion to go out of the Special Call Meeting and into the Public Hearing, Commissioner Sugg made a motion to open the public hearing for the FY 2020-2021 Budget, Commissioner Webb seconded the motion, Motion passed unanimously,

The Finance Officer, Tammy Keesler told the board that this budget was amended and increased by \$8,800 due to the late notice the town received from ECVC pertaining to an increase of their rate from \$60 per ton to \$100 per ton beginning July 1, 2020.

Mayor Harrell opened the floor to public comments at this time. No public comments were made. The Town Administrator did tell the board that she had received a phone call today from James Nash requesting that the board look into purchasing a new fire truck because he felt like they needed one.
